## Introduction

LEHIGH UNIVERSITY is committed to the safety and security of our students, faculty, staff, guests, and the surrounding community. A new Division of Campus Safety was created in 2021, drawing together the Lehigh teams focused on community safety and security; crisis and emergency response; campus law enforcement; crime prevention; and compliance with safety and security regulations.

In this report, Lehigh's Annual Security Report and Annual Fire Safety Report, issued in compliance with the Disclosure of Campus Security Policy and Campus Crime Statistics Act, 20 U.S.C. §1092 (f), also known as the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (Clery Act), you will learn about the many initiatives and programs that support our mission to protect our community.

### **Division of Campus Safety Draws Together Areas Dedicated to Community Safety**

**The new division builds on work to support campus safety and aligns Lehigh's safety services.**

Consistent with best practices in higher education, Lehigh University's new Division of Campus Safety draws together the teams of Lehigh employees whose work focuses on community safety and security; crisis and emergency response; campus law enforcement; crime prevention; and compliance with safety and security regulations, including Jeanne Clery Act Compliance—the objective being increased collaboration and coordination of safety, prevention, and emergency-related functions across the university:



- The Lehigh University Police Department (LUPD) and Security Guards;
- Lehigh's Campus Safety Communications Center (formerly the LUPD Dispatch Center);
- Identification, Electronic Access, and Locksmith (IDEAL) Office;
- Environmental Health and Safety
- Life Safety (including fire prevention); and
- Emergency Medical Services (LUEMS).

Assistant Vice President of Campus Safety and Chief of Police Jason Schiffer says that community members should

feel comfortable calling the newly named Campus Safety Communications Center (610-758-4200) with a safety concern of any kind, and it will be directed to the appropriate area within the division.

The establishment of the Campus Safety Division builds on critical steps Lehigh has taken over time to support campus safety.



## Preparation of the Annual Security Report and Disclosure of Crime Statistics

The Lehigh University Police Department is responsible for preparing and publishing this Report. It does so to inform the Lehigh community about campus security policies and procedures, programs designed to prevent and respond to certain crimes, and specific statistics for certain criminal incidents, arrests, and disciplinary referrals. This report complies with the Clery Act as amended, and uses information collected by the Lehigh University Police Department; information provided by other University offices, such as Housing Services, Residential Life, Office of Student Conduct, the Office of the General Counsel & Title IX Coordinator, Admissions, Human Resources, and Campus Security Authorities; as well as information provided by the City of Bethlehem Police Department and other police departments that have jurisdiction over property owned or leased by the university. Each of these agencies provides updated police information and crime data to the Lehigh University Police Department.

This report provides statistics for the previous three years concerning reported crimes that occurred on campus, in certain off-campus buildings, or on property owned, leased, or controlled by Lehigh University. This report also includes institutional policies concerning campus security, such as policies regarding sexual assault, alcohol, and drugs.

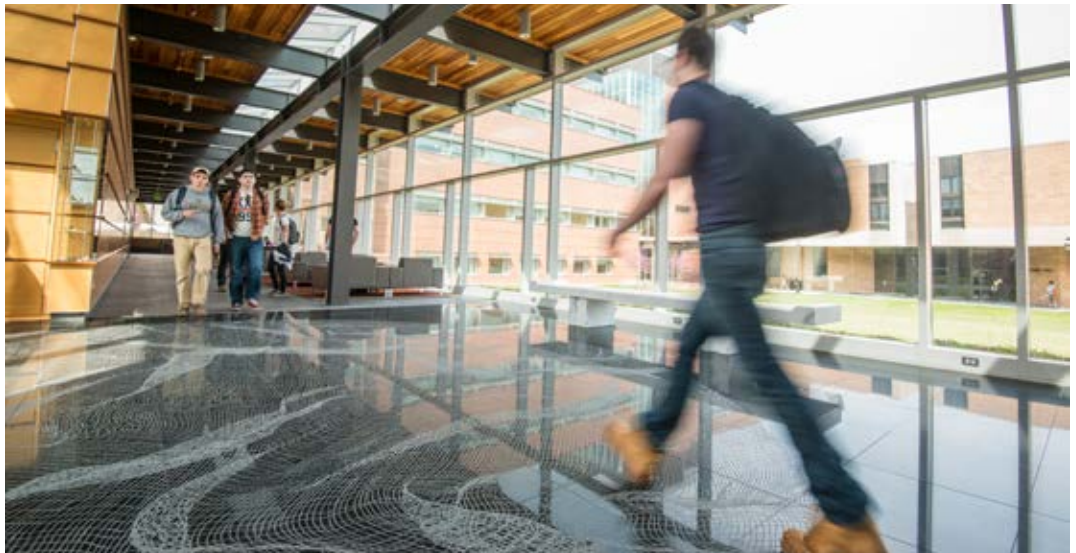

## Campus Safety & Security

Campus safety and security at Lehigh is a shared responsibility. The best protection against campus crime is an aware, informed, and alert campus comprised of students, faculty, and staff who use reason, judgment and caution, in partnership with a dedicated law enforcement department.

The vast majority of our students, faculty, staff and visitors do not experience crime at Lehigh University. However, despite our best efforts, crimes may occur. This information is provided because of our commitment to campus safety and security, and in compliance with the federal law, the Clery Act, the Pennsylvania Uniform Crime Reporting Act (UCR, formerly known as the College and University Security Information Act) and the amendments to the Violence Against Women Act (VAWA) of March 7, 2013. It is meant to be useful to you. If you have concerns, questions, or comments about federal or state law requirements or Lehigh's compliance with these laws, please contact the Office of The Chief of Police at 610-758-4202.

## Lehigh University Police Department

The mission of the Lehigh University Police Department is to aid in the success of our students and our entire campus community by providing a safe environment within which to live and learn. The success of our mission rests on a partnership between the Lehigh University Police Department and the Lehigh community.

The Lehigh University Police Department employs a community policing philosophy and offers a wide variety of public safety programming and educational opportunities. We utilize state-of-the-art technology and have highly trained personnel to assist our community in every way we can.

We operate a dispatch and communications center 24 hours per day, 365 days per year who are ready and trained to assist our community. They can receive calls for service from mobile phones, landline phones, emergency phones located around campus and in elevators, or through the HawkWatch mobile application. The HawkWatch app has various options to contact us, including direct phone calls, mobile blue light with GPS location services, text messaging, and email. Our department is physically located on campus at 321 E. Packer Avenue and operates a community substation with the Bethlehem Police at 324 S. New Street.

## Authority, Training and Jurisdiction

All of Lehigh's police officers are vested with all of the police powers, authority, and responsibilities of any police officer in the Commonwealth of Pennsylvania. Officers of the Lehigh University Police Department have full arrest powers and are armed. All criminal incidents that occur on University property are referred to the the Lehigh University Police Department, which has jurisdiction on campus and in the immediate vicinity surrounding University property.

Statutory authority for the Lehigh University Police Department's existence and the powers of arrest is derived from Pennsylvania law (Title 22 § 501 – Detectives and Private Police), which indicates that our officers, "shall severally possess and exercise all the powers of a police officer in the Commonwealth, in and upon, and in the immediate and adjacent vicinity of, the property of the corporation." All officers employed by Lehigh University are duly appointed by the Northampton County Court of Common Pleas and have sworn an oath required by Article VI of the Constitution of Pennsylvania.

Lehigh officers work in close cooperation with the Bethlehem Police Department and often assist with off-campus investigations. The Bethlehem Police Department has police jurisdiction in the areas around campus property within the City of Bethlehem.

The Lehigh University Police Department is the primary law enforcement authority at Lehigh University. The department has been accredited by the Pennsylvania Chiefs of Police Association since 2007.

The department consists of twenty-six sworn police officers, four full-time security guards, fifteen part-time security guards, six full-time dispatchers, and our business manager. The department rank structure includes a chief and assistant chief, a captain, three lieutenants, four sergeants, and sixteen officers. One of our officers is partnered with a Bethlehem police officer to work with the community members of South Bethlehem and address quality of life issues that concern both permanent residents and students.

The Lehigh University Police Department reports all crimes within our jurisdiction to the Pennsylvania Uniform Crime Reporting System (UCR), which records detailed information about crimes, arrests, and victimization across Pennsylvania. Reports are also shared, if requested, with local police departments.

The department also oversees Clery Act compliance and campus facility security.

## **Safety, Our Number One Priority**

The University takes great pride in the community, and offers many resources for students, faculty, and staff. This community is a wonderful place within which to live, learn, work, and study; however, this does not mean that the campus community is immune from problems that arise in other communities. With that in mind, Lehigh University has taken progressive measures to create and maintain a safe campus environment.

## **Working Relationship with Local, State, and Federal Law Enforcement Agencies**

The Lehigh University Police Department maintains cooperative relationships with the Bethlehem Police Department, Lower Saucon Police Department, Hellertown Police Department, and the Pennsylvania State Police, that allow for intraoperative radio capability, records sharing, joint training programs, special events coordination, and, at times, the joint investigation of serious incidents. The Lehigh University Police Department is currently negotiating the terms of a new Memorandum of Understanding (MOU) with the Bethlehem Police Department. This agreement will authorize police officers and supervisors of the participating agencies to request mutual aid for incidents based upon a reasonable belief that such aid will enhance officer safety and efficiency.

Under our current agreement, the Bethlehem Police Department alerts the Lehigh University Police Department of reported criminal incidents and calls for service made to the county's 9-1-1 Center in those off-campus neighborhoods that are jointly patrolled by both Lehigh University Police and the Bethlehem Police Department. Similarly, any incidents involving any member of the Lehigh community at non-campus locations that fall within the Lehigh patrol area, including incidents involving members of student organizations affiliated with the University, are brought to the attention of the Lehigh University Police Department by the Bethlehem Police Department directly by contacting the department.

## **Prompt & Accurate Reporting of a Crime, Fire, Hazardous Condition Or Suspicious Behavior**

Students, faculty, staff, and visitors are strongly encouraged to promptly and accurately report all crimes and public safety-related incidents to the Lehigh University Police Department, Campus Security Authorities, or the appropriate local police agency. Hazardous conditions

are any conditions that are unsafe or unhealthful. Examples include gas leaks, the presence of hazardous environmental materials, chemical spills, and similar conditions. Suspicious behavior is any behavior that makes you feel unsafe. If it's suspicious to you, it's worth reporting it to the police. Examples include unusual noises, including screaming and the sounds of fighting or breaking glass; people in or around buildings or areas who do not appear to be conducting legitimate business; unauthorized people in restricted areas; vehicles driving aimlessly through campus, surrounding neighborhoods or parking lots; people looking into parked vehicles that are not their own; people who change their behavior when they notice they have been seen; people dressed inappropriately for the weather or occasion (e.g., wearing a heavy coat in warm weather); and the presence of abandoned parcels or other items in unusual locations such as a lobby or elevator. Note that these examples are not an exhaustive list and when in doubt, we encourage you to make a report.

We encourage the reporting of crimes including when the victim does not elect to, or is unable to, make such a report. Crimes and incidents should be reported as soon as possible so that Lehigh may assess the need for a timely warning or emergency notification, and assess the need for inclusion in the annual statistical disclosure.

Additionally, all criminal and fire-related incidents should be reported as soon as possible to the Lehigh University Police Department to assist with timely response, accurate documentation, and the exchange of important information among city, state and federal authorities.

The Lehigh University Police Department monitors all calls for service made directly to the city 9-1-1 Center, 24 hours per day, 7 days per week.

#### HawkWatch Personal Safety App:

The HawkWatch personal safety app is offered for free to all members of the campus community. There is no obligation to download this app, but it is strongly encouraged. The HawkWatch app is custom-designed for Lehigh University and includes a number of options that can help in an emergency situation. It also puts the user in direct contact with Campus Safety dispatchers. It is the equivalent of a mobile blue light phone in the palm of the user's hand. In addition, the app provides quick and easy access to useful information such as directions in emergency situations, and emergency contacts and support resources. It can also serve as a Lehigh bus tracker, provide links for reporting a tip, and offer users a quick and easy way to request safety programs.

### Crimes Involving Students at Off-Campus Locations

The US. Department of Education requires the University to address whether it is aware of any practice by local police to monitor and document criminal activity by Lehigh students occurring at "noncampus locations of student organizations." As such, the Lehigh University Police Department relies on its close working relationship with the Bethlehem Police Department to receive information about off-campus incidents involving Lehigh University students and recognized student organizations. In coordination with local law enforcement agencies, the Lehigh University Police Department will assist with the investigation of certain crimes occurring near campus. External law enforcement agencies will formally notify the Lehigh University Police Department, which will subsequently notify the Lehigh University Office of Student Conduct of criminal activity involving student perpetrators. The Lehigh University Police Department will also notify the Dean of Students office regarding any Lehigh students identified as crime victims to ensure proper resources and support are provided.

Lehigh University requires all recognized student organizations to abide by federal, state, local laws, and

University regulations. Lehigh University may become involved in the off-campus conduct of a student or student organization when such conduct is determined to affect a substantial University interest, as defined in the Student Code of Conduct located at <https://studentaffairs.lehigh.edu/content/code-conduct>.

### Campus Security Authority (CSA)

A Campus Security Authority (CSA) is an individual who is a Lehigh University official of the institution, and who has significant responsibility for student and campus activities, including, but not limited to:

- Lehigh University Police Department Staff
- Residence Life Staff / Gryphons
- Dean of Students Staff
- Office of Fraternity and Sorority Affairs
- Housing Services Staff
- Physicians in the Health & Wellness Center
- Directors of Athletics and Team Coaches
- Office of Student Conduct Staff
- Academic Advisors
- Title IX/EOCC
- Faculty and Staff Advisors to student groups

Under the Clery Act, a Clery-reportable crime is reported when a victim, witness, other third party, or even the offender brings it to the attention of a CSA or of local law enforcement personnel. It does not matter whether the individual/s involved in the crime, or in the reporting of the crime, are associated with the University. If a CSA receives crime information, and believes it to have been provided in good faith, he or she must document it as a crime report and provide that report to the Lehigh University Police Department. Reporting a crime in "good faith" means that the reporter has a reasonable basis to believe that the information received is not simply rumor or hearsay. CSAs are not responsible for investigating crimes; their role is to appropriately report all incidents that occur on Clery Geography immediately, no matter how minor they may seem. Any subsequent investigations and crime classifications are the responsibility of sworn law enforcement personnel.

A training session is conducted annually for the University's CSAs. Additionally, all newly hired security guards receive in-person CSA training as part of their orientation. All security guards and event staff also receive annual CSA training. All CSAs are provided with resources to report crimes to the Lehigh University Police Department.

Pastoral counselors and licensed mental health professionals are not considered to be CSAs under the Clery Act. A pastoral counselor is defined as a person who is associated with a religious order or denomination, is recognized by that religious order or denomination as someone who provides confidential counseling, and, at the time of the crime report, is functioning within the scope of that recognition as a pastoral counselor. A licensed mental health professional is defined as a person whose official responsibilities include providing mental health counseling to members of the University community, and who is functioning within the scope of his or her license or certification at the time that the crime report is received. This definition also applies to professional counselors who are not employees of the University, but are under contract to provide counseling at the University.

Lehigh does encourage its pastoral counselors and licensed mental health professionals, only if and when they deem it appropriate, to verbally inform persons whom they are counseling of the University's procedures for reporting crimes on a voluntary, confidential basis for statistical inclusion in this Report. In this situation, and only with the permission of the victim, the licensed mental health professional can submit a report to the University Police, detailing the incident without revealing the identity of the victim. The purpose of this type of report is to respect an individual's wish to keep personally identifying information confidential, while taking steps to ensure an accurate record of the number of incidents; determine where there is a pattern of crime with regard to a particular location, method or assailant; and alert the University community to potential danger. Reports filed in this manner may be counted and disclosed in the annual crime statistics for the institution, and may result in a timely warning or emergency notification.



## Confidential Crime Reporting

Except for the referenced reports made to pastoral counselors and licensed professional counselors, all Campus Security Authorities are obligated to report all Clery Act offenses to the Lehigh University Police Department. It is also important for University CSAs to report statistical information, which may not include personal information. Confidential reports that provide sufficient detailed information for classification of the offense by law enforcement officials using FBI Uniform Crime Reporting Guidelines will be included in crime statistics. Crimes may be reported online at <https://police.lehigh.edu/content/report-crime>.

## Timely Warnings

Lehigh will issue Timely Warnings to the campus community for Clery-reportable crimes occurring on its Clery Act Geography, when such crimes are reported to Campus Security Authorities or to local police agencies and considered by the University to represent serious or continuing threats to students and employees. For definitions of Clery Act Offenses and Clery Act Geography, see the section of this report on the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics starting on page 34, with the definitions beginning on page 34. The Clery definitions can be found at: <https://police.lehigh.edu/content/clery-act-reportable-crimes>. Whether an incident constitutes a serious or continuing threat to students and employees is a case-by-case determination that may take into account the following criteria: (1) a Clery-reportable crime is reported; (2) the perpetrator has not been apprehended; and (3) there is a substantial risk to the safety of other members of the campus community because of this crime.

Lehigh University may issue Timely Warnings for the following: arson; aggravated assault; criminal homicide; domestic violence; dating violence; robbery; burglary; motor vehicle theft; sexual assault; hate crimes; and stalking. The University also may issue a Timely Warning for alcohol, drug, and weapon arrests or referrals that may cause a continuing threat to the campus community.

Lehigh University will distribute Timely Warnings (<https://police.lehigh.edu/content/clery-act-timely-warnings-and-emergency-notifications>) to the entire campus community through a variety of methods, including, but not limited to: campus-wide emails, desktop notifications, classroom announcements, web postings, and social media. The University also has the ability to

send push notifications and text message alerts through HawkWatch.

At Lehigh University, the Office of the Chief of Police will, generally, review all reports to make the determination, and in consultation with other offices, such as University Communications, make the decision as to whether a Timely Warning is required. However, in emergency situations, any police supervisor and/or police dispatcher may authorize a Timely Warning. For incidents involving off-campus crimes, the University may issue a Timely Warning if the crime occurred in a location used and frequented by the University population. Although the Clery Act does not define “timely,” the intent of such a warning is to enable our community to protect itself. This means that a warning is issued as soon as pertinent information is available and verified, so that it can be used as a preventive tool, and not solely constitute a description of the incident.

The amount and type of information presented in a Timely Warning will vary depending on the specific facts and circumstances of the crime. If there is certain information that could compromise law enforcement efforts, those facts may be withheld from the Timely Warning notice. Generally, the warning will specify the type of crime reported, the time and location at which the reported crime occurred, and specific advice to the campus community regarding steps to take to avoid becoming a victim.

In certain circumstances, an incident may not meet the criteria of a Clery-reportable crime occurring in a Clery-reportable location, but may constitute a serious or ongoing threat to the campus community. For such instances in which Timely Warnings are not required, the Chief of Police, or a designee, may choose to issue an “Alert,” notifying the Lehigh community of the threat. The content of such an Alert may vary depending on the type of incident reported and the location in which it occurred.

## Emergency Notifications

The decision to initiate an emergency notification usually starts with the Lehigh University Police Department at the point of confirming a significant emergency or dangerous situation occurring on the campus that involves an immediate threat to the health or safety of students or employees. Predicting how and when crisis situations will strike is difficult, so preparation is critical. Depending on the nature of an emergency, certain members of the Crisis Management Team, including the Operations Group, or their designee, are notified and come together to make

determinations about, among other things, confirming the existence of the emergency or dangerous situation, initiating the emergency notification system, determining the appropriate segments of the campus to receive an emergency notification, and determining the content of the emergency notification and the notification procedures utilized as described below. The Lehigh University Police Department engages University Communications to review language as appropriate and send notifications if the police are otherwise engaged in responding to a situation. The determination of point persons is made on a case-by-case basis depending on the nature of the situation.

### Confirming the Existence of a Significant Emergency or Dangerous Situation, and Initiating the Emergency Notification System

The Lehigh University Police Department will work with local authorities, when appropriate, to confirm whether the incident constitutes a “significant emergency or dangerous situation occurring on the campus that involves an immediate threat to the health or safety of students or employees,” such that an emergency notification is warranted.

Upon confirmation of a significant emergency or dangerous situation occurring on the campus that involves an immediate threat to the health or safety of students or employees, the Lehigh University Police Department, in consultation with University Communications, will, without delay, and taking into account the safety of the community, determine the content of the notification, and initiate the notification system, unless issuing a notification would, in the professional judgment of the first responders, compromise efforts to assist a victim or to contain, respond to or otherwise mitigate the emergency.

### Determining the Appropriate Segment(s) of the Campus Community to Receive an Emergency Notification

Generally, campus community members in the immediate area of the dangerous situation (i.e., the building, adjacent buildings, or surrounding area) will receive the emergency notification first. The Lehigh University Police Department will continually evaluate the situation and assess the need to notify additional segments of the campus population (consulting with University Communications as needed).

### Determining the Content of the Emergency Notification

Generally, the Lehigh University Police Department will identify the situation, the location, and the immediate protective action that should be taken, consulting with University Communications on appropriate messaging as needed.

## Procedures Used to Notify the Campus Community

In the event of a situation that poses an immediate threat to members of the campus community, the campus has various systems in place for communicating information quickly. Some or all of these methods of communication may be activated in the event of an emergency. These methods of communications include the following:

### HawkWatch alerts

HawkWatch alerts include text messages, push notifications, emails, desktop notifications and voicemail messages sent to the campus community in the event of an emergency or a weather circumstance that may impact normal campus operations. ### Sirens

Sirens on all campuses serve as notification that there is imminent danger and that more information should be sought via the University website, <https://www1.lehigh.edu/emergency/prepared/siren>.

### Classroom announcements

Classroom announcements are relayed via speakers in classrooms across campus.

### Safety Bulletins

Safety Bulletins are emails sent to the campus community to advise on health and safety issues.

Telephone messages at 610-758-NEWS are updated when an emergency happens or when the campus is closed or opening is delayed due to weather.

### Official Facebook and Twitter pages

Official Facebook and Twitter pages are utilized to convey the status of an emergency situation or to relay a closing due to inclement weather as well as to monitor the accuracy of campus interpretations of emergency circumstances. ### Website updates and banners

Website updates and banners are placed on the University home page to repeat what is sent out via HawkWatch Alerts.

### Call Center

A call center can be activated with trained campus or other staff to take calls and provide answers when campus operators are overwhelmed.

## Testing Emergency Response and Evacuation Procedures: Drills, Exercises, and Training

To ensure that campus emergency management plans remain current and actionable, Lehigh conducts tests of equipment and procedures to assess and evaluate the emergency response plans and capabilities of the University. These tests may be announced or unannounced and include both exercises and drills. Lehigh will document for each test: a description of the exercises, the date, the time, and whether it was announced or unannounced. Each year, Lehigh will remind the community of the University's emergency notification system and emergency response procedures. Further information for fire-specific safety drills, exercises and training can be found on page 42.

## Emergency Evacuation Procedures

The campus of Lehigh University is located on both sides of a mountain surrounded by the city of Bethlehem on the north side and residential communities on the south side. In the event a crisis occurred where the whole campus needed to be evacuated quickly, an evacuation would be ordered by the Chief of Police. The only time this would occur is if all the buildings were at risk or were considered uninhabitable. An example of this might include an earthquake, tornado or large-scale fire where all the living areas were damaged or at risk of severe damage.

In general, the evacuation procedures due to an emergency event such as a building fire alarm, chemical spill, or gas leak for each building should be followed and the general evacuation procedures would apply:

- All fire alarms should be treated as an actual emergency situation and all appropriate protocols should be followed by everyone without exception.
- When the fire alarm sounds, evacuation of the building is mandatory.
- Do not use elevators.
- Contain fire by closing doors and windows prior to exiting the building.
- Take personal belongings (keys, cellphones, purses, etc.) and weather-appropriate clothing with you as you leave the building.
- If time permits, secure any hazardous, sensitive or confidential materials prior to leaving your area.
- Go to the nearest emergency exit of the building and proceed to the rally point. Know the primary and secondary rally site for each building you frequent during the workday.
- All rally sites should be located a minimum of 150 feet from your building and must not impede the



movement of emergency vehicles/responders at the site of the incident.

- If you frequent several buildings on campus and do not know where each rally site is located, please do one of the following to be prepared: speak with the building monitor in that building to identify the location of the rally sites, contact Environmental Health & Safety, follow the suggestion listed above (move 150 feet away from the building to a location that does not impede the progress of emergency vehicles or responders).
- Individuals are instructed to not return to the evacuated building until advised to do so by emergency personnel or the individuals conducting the proactive emergency drill.

### The Lehigh University Police Department

The Lehigh University Police Department and other first responders will also provide on-site direction in the event of an emergency at <https://police.lehigh.edu/>. At least twice per year, we test our emergency communications systems, including HawkWatch messaging and the campus sirens, to ensure that they are fast and reliable. Additionally, the Crisis Management Team conducts monthly meetings to discuss hypothetical scenarios and/or to evaluate real experiences (at Lehigh or on other campuses) in order to maintain an active state of preparation for emergencies of all types. The work of the Crisis Management Team is audited periodically by risk management professionals.

### Crisis Management Team

Planning for possible emergencies of all types is undertaken with diligence. A disaster and emergency preparedness plan has been assembled. It includes more than two dozen department/unit protocols for responding to specific emergencies, developed under the guidance of the Office of Risk Management, the Office of the General Counsel and the Director of Health and Environmental Safety using best practices. The plan is evaluated and reviewed regularly, and practiced locally, as appropriate or required.

In the event of a crisis, or even when unusual occurrences unfold on or around the campus, a team of senior campus leaders, called the Crisis Management Team, initiates internal information sharing and dialogue as needed. Their primary focus is to provide leadership and policy decision-making, the capability to mobilize necessary resources, to support the operational experts that are normally the first responders to a campus emergency/crisis situation (campus police, environmental



safety staff, student life personnel, etc.), and to ensure that the President and Board of Trustees are kept informed. Additionally, the Crisis Management Team assesses the possible impact of the circumstances on our campus community members and campus operations and determines the need for additional communications, decisions, or University responses to the specific emergency/crisis. ### Volunteering in a Crisis

Severe weather, power outages and other crises affecting campus are best dealt with by planning ahead. Lehigh has a resource where eligible faculty and staff may sign up in advance to volunteer when a crisis occurs, as well as specify the types of volunteer service they can provide. With an up-to-date volunteer database, Lehigh University will have a quick access to potential volunteers to assist at a moment's notice. ### Be Prepared

Emergencies, disasters or accidents can happen at any time or without warning. Potential emergencies at Lehigh University, both natural and man-made, may require that community members be prepared to evacuate from University buildings.

Students, faculty and staff should become familiar with University buildings and be familiar with the following guidelines:

- Know at least two building exits other than the elevators.
- Know the location and operation of the building fire alarm system.
- Know emergency phone numbers.
- Know the building monitor in your area/building, along with your primary rally site and alternate site. For more information on the Building Monitors Program, visit the

- Participate in all announced and unannounced fire drills.
- Begin to evacuate at the first sign of smoke, fire alarm or an evacuation notice.
- Do not return to your building until cleared by on-location emergency personnel or you are notified by an official campus communication.
- Download the HawkWatch personal safety app, which puts the user in direct contact with the Campus Safety dispatcher, provides critical information on how to respond to emergency situations, tracks Lehigh University buses and allows the user to quickly access emergency resources. There are also options such as "Friend Walk," which allows the user to connect with friends who can chart the users' movements as they make their way to the desired location. ### For Researchers

Unplanned or spontaneous events often disrupt daily operations on campus. In the event that an incident may interrupt your laboratory or facility operations, preparation of an emergency shutdown plan is essential. ## Security of and Access to Campus Facilities

All residential units are equipped with electronic locks that open with a Lehigh Student ID card. These buildings are also equipped with alarm systems that automatically alert Lehigh University police when an exterior door is propped open. All exterior residence hall doors are locked 24 hours a day. Section and fire doors are to be kept closed at all times, and residents are expected to abide by this policy by refraining from blocking or propping doors open. Security screens have been installed on accessible windows in residence halls.

There are more than 150 buildings at Lehigh. Access to open buildings, events, and programs is granted to all students, faculty and staff with a Lehigh ID card. Everyone affiliated with the University is expected to carry their Lehigh ID card at all times. Upon request by an officer of the University, the person must show the ID card. All University owned and operated residential facilities are locked 24 hours per day. Access is limited to residents, their guests, staff, or those hired by the University to provide specific services. Non-residential facilities are locked and secured on a variety of schedules consistent with the usage of the building and the time of the academic year. Academic buildings typically are unlocked Monday through Friday between 7:00 a.m. and 6:00 p.m. and are accessible by card access for all students, faculty and staff during the evening hours and over the weekend. When non-residential buildings are closed, only those staff or students with appropriate authorization are permitted entry. Students, faculty, and staff are expected to be aware of, and abide by, these regulations. Certain buildings are equipped with alarms to alert Lehigh police of unauthorized entrance. In addition, the Lehigh University Police Department employs security guards who conduct foot patrols throughout the campus. The security guards check exterior doors, visually monitor activity in and around campus facilities, and walk through the buildings. Unauthorized individuals found in closed buildings are evicted and subject to other action as appropriate.

### Security Technology

The Lehigh University Police Department assists with the installation and maintenance of a state-of-the-art electronic security infrastructure across the University. This includes more than 200 emergency phones connected directly to our Campus Safety Communications

Center, along with more than 400 closed-circuit television (CCTV) cameras throughout campus. To view an interactive map of the entire Lehigh Campus indicating where these emergency phones are located, please visit <https://www2.lehigh.edu/map>.

The Lehigh University IDEAL Office is responsible for identification, electronic access, and locksmiths and they report to the Police Department. The IDEAL Department controls all electronic access control card readers, burglar and door alarms, sensors, and other key features of the security technology located in Lehigh-owned buildings throughout campus.

## Statement Regarding Sexual Harassment, Sexual Misconduct, Dating Violence, Domestic Violence, and Stalking, and What to Do if You are a Victim of a Crime Regarding Same

Lehigh University has adopted a policy that prohibits sexual assault, domestic violence, dating violence, and stalking. Lehigh encourages everyone to read the full Policy, as it applies to students, faculty, and staff. The Policy, among other things, describes prohibited conduct; explains options for reporting; describes the procedures that the University will follow for promptly, thoroughly, and equitably investigating and resolving reports; and implements the requirements of Title IX and the Clery Act. The information below is distributed to students and employees in the following ways: by email, publication on various websites, and with hard copies upon request.

What follows below in the next section are certain statements of policy that the Clery Act requires the University to provide in this Report. To the extent there are any discrepancies between the statements below and the Policy, the Policy controls.

As noted above, the following information is drawn from Lehigh University's Policy on Harassment and Non-Discrimination and Student Handbook.

Lehigh University considers sexual harassment, sexual assault (including rape, fondling, statutory rape and incest), sexual exploitation, intimate partner abuse (including domestic violence and dating violence), and stalking (for purposes of this Report, collectively "Sex-Based

Misconduct”) to be acts that cannot be tolerated within the academic and residential environment of a caring community. Lehigh University will not tolerate Sex-Based Misconduct violence toward, or abuse of, any member of the community by another. Such violence and/or abuse includes sexual assault, intimate partner abuse, sexual exploitation, stalking, sexual harassment and any other forms of sex-based violence or sex-based stalking perpetrated against any student, faculty member, staff member or any other person in the Lehigh University community. All members of the University community and visitors to campus are encouraged to report incidents of such misconduct to the persons listed below. We will further encourage victims, when applicable, to seek criminal prosecution under the Pennsylvania Crimes Code.

Lehigh University is committed to providing prompt support services to any victims of Sex-Based Misconduct. If you or anyone you know has been a victim of Sex-Based Misconduct at Lehigh University, your first priority should be to:

**1. When applicable, seek medical attention immediately:** For a sexual assault, evidence can only be collected at a hospital emergency room by a specially trained SAFE (Sexual Assault Forensic Examiner) or SANE (Sexual Assault Nurse Examiner) nurse within 96 hours of any sexual assault. In addition to collecting evidence, health concerns such as sexually transmitted infections (STIs), pregnancy, and treatment of injuries will be addressed. For any crime, it is important for you to collect and bring with you any evidence because, although you may not want to pursue criminal action immediately, you may change your mind in the future. To preserve evidence, don’t bathe or shower, use the restroom, change your clothes or brush your teeth. Collect and maintain everything that may be important



for a criminal investigation, whether the conduct was sexual assault, dating violence, domestic violence, stalking, or otherwise.

**2. Consider reporting the incident:** Lehigh University encourages individuals to report all cases of Sex-Based Misconduct to the Lehigh University Police Department at 610-758-4200, and to, Karen Salvemini, Lehigh’s Equal Opportunity Compliance Coordinator, who also serves as the University’s Title IX Coordinator, at 610-758-3535.

Reports can also be made by completing the appropriate online reporting form at: [lehigh.edu/go/genderviolencereport](https://lehigh.edu/go/genderviolencereport). When submitted, it will be received by the University police and the Title IX Coordinator.

Students may also contact a Lehigh University Gender Violence Support Advocate, who will report the incident to the University police as well as to the Title IX Coordinator.

The University prohibits retaliation against, and intimidation or harassment of, anyone who reports or is believed to have reported harassment (including Sex-Based Misconduct) or discrimination, or who is a witness to or otherwise involved in a harassment (including Sex-Based Misconduct) or discrimination.

When a student or employee reports to the institution that they have experienced Sex-Based Misconduct, whether the offense occurred on or off campus, Lehigh will provide those impacted individuals with information regarding their options for involving local law enforcement, including notification of the options to:

- notify proper law enforcement authorities, including University and/or local police;
- be assisted by campus authorities in notifying law enforcement authorities if the complainant so chooses; and
- decline to notify such authorities.

The process for filing a police report may vary by department. In most cases, however, after addressing the person’s immediate safety needs and/or needs for medical care, a law enforcement officer will meet with the person and take a statement about what occurred. In cases of sexual violence or relationship violence, in addition to taking a statement, the law enforcement officer may ask to examine the scene of the incident and collect bedding, clothing, or other items of evidentiary value. The length of the law enforcement interview may vary depending on the circumstances of the case, and multiple interviews may be required.

Lehigh will cooperate with law enforcement agencies if a person decides to pursue the criminal process, to the extent permitted by law. However, Lehigh policy may differ in significant respects from criminal law. Neither law enforcement's determination whether to prosecute, nor the outcome of any criminal prosecution, is determinative of whether a University policy violation occurred. Procedures under University policy may be carried out prior to, simultaneously with, or following civil or criminal proceedings off campus.

**3. Get support:** A representative of the LUPD and/or the Title IX Coordinator and/or a University Advocate will guide you through the available options and support you in your decision. You will be provided with written information regarding resources and options. There are numerous resources available both on and off campus to provide you with support after an incident of Sex-Based Misconduct. These include:

## Applicable Pennsylvania Statutes

### Pennsylvania's Criminal Definition of "Consent"

Although the statutes of the Commonwealth of Pennsylvania do not contain a specific definition of "consent" in the context of dating violence, domestic violence, sexual assault, or stalking, the Pennsylvania statutes do contain a general definition of "consent" as it pertains to crimes under the Pennsylvania Crimes Code.

### 311. Consent.

- (a) **General rule.**—The consent of the victim to conduct charged to constitute an offense or to the result thereof is a defense if such consent negatives an element of the offense or precludes the infliction of the harm or evil sought to be prevented by the law defining the offense.
- (b) **Consent to bodily injury.**—When conduct is charged to constitute an offense because it causes or threatens bodily injury, consent to such conduct or to the infliction of such injury is a defense if:
  - (1) the conduct and the injury are reasonably foreseeable hazards of joint participation in a lawful athletic contest or competitive sport; or
  - (2) the consent establishes a justification for the conduct under Chapter 5 of this title (relating to general principles of justification).
- (c) **Ineffective consent.**—Unless otherwise provided by this title or by the law defining the offense, assent does not constitute consent if:
  - (1) it is given by a person who is legally incapacitated to authorize the conduct charged to constitute the offense;
  - (2) it is given by a person who by reason of youth, mental disease or defect or intoxication is manifestly unable or known by the actor to be unable to make a reasonable judgment as to the nature or harmfulness of the conduct charged to constitute the offense;
  - (3) it is given by a person whose improvident consent is sought to be prevented by the law defining the offense; or
  - (4) it is induced by force, duress or deception of a kind sought to be prevented by the law defining the offense.

## Defining Sexual Assault/Rape, Domestic Violence, Dating Violence and Stalking

### Sexual Assault:

Under Pennsylvania law, sexual assault occurs when a person engages in sexual intercourse or deviate sexual intercourse with a complainant without the complainant's consent.

The Clery Act defines Sexual Assault as any sexual act directed against another person, without consent of the victim, including instances where the victim is incapable of giving consent. This includes Rape, Fondling, Incest, and Statutory Rape as defined by the Clery Act.

**Rape:**

Under Pennsylvania law, rape occurs when a person engages in sexual intercourse with a complainant: (1) by forcible compulsion; (2) by threat of forcible compulsion that would prevent resistance by a person of reasonable resolution; (3) who is unconscious or where the person knows that the complainant is unaware that the sexual intercourse is occurring; (4) where the person has substantially impaired the complainant's power to appraise or control his or her conduct by administering or employing, without the knowledge of the complainant, drugs, intoxicants or other means for the purpose of preventing resistance; or (5) who suffers from a mental disability which renders the complainant incapable of consent.

The Clery Act defines Rape as the penetration, no matter how slight, of the vagina or anus, with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. This offense includes the rape of both males and females.

**Domestic Violence:**

Domestic Violence is not defined by Pennsylvania state statute. Under Pennsylvania Protection From Abuse Act, however, "abuse" is defined as the occurrence of one or more of the following acts between family or household members, sexual or intimate partners or persons who share biological parenthood: (1) Attempting to cause or intentionally, knowingly or recklessly causing bodily injury, serious bodily injury, rape, involuntary deviate sexual intercourse, sexual assault, statutory sexual assault, aggravated indecent assault, indecent assault or incest with or without a deadly weapon. (2) Placing another in reasonable fear of imminent serious bodily injury. (3) The infliction of false imprisonment pursuant to 18 Pa.C.S. § 2903 (relating to false imprisonment). (4) Physically or sexually abusing minor children, including such terms as defined in Chapter 63 (relating to child protective services). (5) Knowingly engaging in a course of conduct or repeatedly committing acts toward another person, including following the person, without proper authority, under circumstances which place the person in reasonable fear of bodily injury. The definition of this paragraph applies only to proceedings commenced under this title and is inapplicable to any criminal prosecutions commenced under Title 18 (relating to crimes and offenses).

The Clery Act defines Domestic Violence as a felony or misdemeanor crime of violence committed—

- By a current or former spouse or intimate partner of the victim;

- By a person with whom the victim shares a child in common;
- By a person who is cohabitating with, or has cohabitated with, the victim as a spouse or intimate partner;
- By a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred;
- By any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred.

**Dating Violence:**

Dating Violence is not specifically defined by Pennsylvania state statute. The Clery Act defines Dating Violence as violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim. The existence of such a relationship shall be determined based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship. Dating violence includes but is not limited to sexual or physical abuse or the threat of such abuse. However, it is important to recognize that emotional, verbal, and economic abuse are part of the web of dating violence and can exist without the presence of physical abuse.

**Stalking:**

Under Pennsylvania law, stalking occurs when a person either: (1) engages in a course of conduct or repeatedly commits acts toward another person, including following the person without proper authority, under circumstances which demonstrate either an intent to place such other person in reasonable fear of bodily injury or to cause substantial emotional distress to such other person; or (2) engages in a course of conduct or repeatedly communicates to another person under circumstances which demonstrate or communicate either an intent to place such other person in reasonable fear of bodily injury or to cause substantial emotional distress to such other person.

The Clery Act defines Stalking as engaging in a course of conduct directed at a specific person that would cause a reasonable person to—

- Fear for the person's safety or the safety of others; or
- Suffer substantial emotional distress.

Information about these Pennsylvania statutes is made available through distribution of this Report.



## Lehigh University Non-Discrimination Statement and Title IX Notice of Non-Discrimination

### Non-Discrimination Statement

Lehigh University upholds The Principles of Our Equitable Community and is committed to providing an educational, working, co-curricular, social, and living environment for all students, staff, faculty, trustees, contract workers, and visitors that is free from harassment and discrimination on the basis of age, color, disability, gender identity or expression, genetic information, marital or familial status, national or ethnic origin, race, religion, sex, sexual orientation, or veteran status. Such harassment or discrimination is unacceptable behavior and will not be tolerated.

The University strongly encourages (and, depending upon the circumstances, may require) students, faculty, staff or visitors who experience or witness harassment or discrimination, or have information about harassment or discrimination in University programs or activities, to immediately report such conduct.

### Disciplinary Procedures/Policy Statements

Lehigh University has developed fair, prompt and impartial processes, from the initial investigation to the final result, for matters that involve harassment and sexual misconduct (including but not limited to dating violence, domestic violence, sexual assault, stalking and sexual exploitation). When the facts and circumstances indicate that the situation may involve sexual harassment as that term is defined by the federal Title IX regulations finalized in May 2020 (34 C.F.R. 106), as incorporated into University policies, (otherwise referred to as “Title IX Sexual Harassment” throughout this section) the process used to resolve these matters typically involves an investigation by two trained investigators and, absent informal resolution, a live hearing conducted by a panel of three trained faculty and staff members. These individuals, and everyone involved in the Title IX Sexual Harassment process, receive annual training on the issues related to dating violence, domestic violence, sexual assault, and stalking and on how to conduct an investigation and hearing process that protects the safety of the complainant and promotes accountability. If the matter gets to a panel, the panel determines whether the individual violated applicable University policy.

The process used to resolve matters involving sexual misconduct or harassment that does not meet the

definition of Title IX Sexual Harassment can best be described as a civil rights investigative model. While the investigative process remains the same, the individuals who investigate and who are responsible for determining whether a violation of University policy occurred are dependent on the role of the person who allegedly violated the applicable University policy. In other words, faculty cases are resolved by the Provost’s Office, staff cases are resolved by the appropriate Senior Officer within the respondent’s reporting line, and student cases are resolved by a three-person panel comprised of faculty and staff.

### Processes and Procedures

The following is an outline of the process and procedures used by Lehigh University to resolve issues involving harassment and sexual misconduct. The complete information can be found online:

### Filing a Report with Law Enforcement

If a student or employee feels unsafe; has experienced or witnessed dating violence, domestic violence, sexual assault, stalking, sexual exploitation or any other form of sexual harassment or sexual misconduct; or would like to file a report with the police, please contact:

The Lehigh University Police Department (LUPD) is fully accredited by the Commonwealth of Pennsylvania and is available 24/7 throughout the year. If a report is filed, the police will take appropriate steps in response to the report. If the conduct occurred outside LUPD’s jurisdiction, LUPD will assist in reporting the incident to the proper law enforcement authorities in the applicable jurisdiction.

### Filing a Report or Complaint with the Title IX Coordinator

Faculty, staff, and students who have experienced dating violence, domestic violence, sexual assault, stalking,

sexual exploitation, or any other form of sexual harassment or sexual misconduct, or have information about such conduct, should immediately notify the Equal Opportunity Compliance Coordinator (EOCC)/Title IX Coordinator. This administrator will assist the impacted individual in determining whether the complained-of conduct is Title IX Sexual Harassment, harassment of some other type, or something else, and make sure appropriate processes are explained.

Faculty, staff, and students may make a report to both the police and the University, or may decline to notify either entity. University resources will assist with notifying LUPD if an incident of dating violence, domestic violence, sexual assault, stalking, sexual exploitation, or other form of sexual harassment or sexual misconduct has occurred, if the survivor so chooses. A report may also be filed online simultaneously with both LUPD and the University by completing and submitting the online Gender Violence Reporting Form, available on

the EOCC and Gender Violence Education and Support websites or at <http://www.lehigh.edu/go/gvreport>.

### **Initial Steps and Supportive Measures**

Generally within 72 hours of receiving a report of sexual harassment, dating violence, domestic violence, sexual assault, stalking, or sexual exploitation, the Title IX Coordinator will contact the impacted student or employee to set up a time to meet to discuss the student or employee's options and rights. The Title IX Coordinator will also refer the individual to the appropriate policy for more information.

The Title IX Coordinator provides written notification to students and employees about existing counseling, health, mental health, victim advocacy, and other services available to impacted individuals, both within the institution and in the community. Contact information for these services is available under the "Get Support" section of this Report.

During this initial contact with the Title IX Coordinator, a determination will be made regarding supportive measures to provide for the safety of the impacted individual (who may also be known as a "complainant") and the campus community while being mindful of the rights of the accused individual (who may also be known as a "respondent").

For students, the range of protective/supportive measures may include, but are not limited to, interim suspension/emergency removal from the institution, transportation changes, interim removal from housing, adjustments to academic classes or University residence assignments, access to counseling services, the issuance of University no-contact orders, etc.

For faculty and staff, the range of protective/supportive measures may include, but are not limited to, temporary work restrictions and/or changes, transportation changes, interim leave, and University no-contact orders.

Supportive measures are available to students, faculty, and staff to the extent that the requested measure(s) is reasonably available, regardless of whether the impacted individual reports the conduct to the police or proceeds with a University process. Information about options for supportive measures is provided in writing to students, faculty, and staff. Students, faculty, and staff requesting a supportive measure should contact the Title IX Coordinator. To the extent possible, when implementing supportive measures, the University shall take steps to minimize the burden on and respect the rights of the respondent. The University also takes steps to maintain as

confidential any supportive measures that are provided, to the extent that maintaining confidentiality does not impair the University's ability to implement such measures. The Title IX Coordinator is responsible for determining the information about the complainant that is disclosed, and to whom it is disclosed. The Title IX Coordinator makes this determination by considering what assistance is required to assess and implement the supportive measures, such as contacting the Office of Residence Life and Office of Housing Services to alter housing arrangements.

Faculty, staff, and students may also file a petition at the local courthouse for a civil (non-criminal) protection order that offers victims of certain crimes relief from further harm from a perpetrator. Pennsylvania offers three different civil protection orders, including protection from abuse orders, sexual violence protection orders, and protection from intimidation orders. The qualifications for these protection orders vary per order. For more information about obtaining a civil protection order, contact the Title IX Coordinator, Crime Victims Council of the Lehigh Valley (<https://cvclv.org/>), Turning Point of the Lehigh Valley (<https://www.turningpointlv.org/>), or an attorney to discuss your options.

If criminal charges are filed, faculty, staff, and students may also request a temporary "stay away" court order issued by a judge for a period of one year or until the associated criminal case is resolved.

The Title IX Coordinator will contact the respondent to inform that person of an investigation, any no-contact orders or supportive measures that are being taken that may impact the respondent, and of their rights and responsibilities in the process.

Both the complainant and the respondent may have an advisor of their choosing (including counsel) present at any meetings held during the grievance process (defined in Section 1.8.9 of the Policy on Harassment and Non-Discrimination as "the processes established in Sections 5.6.3 (Formal Grievance Process) and 6.3 (Formal Resolution) which are disciplinary methods designated by the University to address conduct within the definitions of prohibited conduct under this Policy"). In cases involving Title IX Sexual Harassment, each party must be accompanied by an advisor at the live hearing. In cases involving other forms of sexual harassment or sexual misconduct, the advisor may not represent or speak for the party, but may provide advice. In accordance with the Clery Act, Lehigh does not limit the choice of advisor, or presence of the advisor, for either the complainant or the respondent in any meeting or institutional disciplinary proceeding; however, it may

establish restrictions regarding the extent to which the advisor may participate in the proceedings. Any restrictions apply equally to both parties.

In a Title IX Sexual Harassment case, a resolution process pursuant to University policy will not move forward until a formal complaint has been signed by the complainant or the Title IX Coordinator. The Title IX Coordinator may, but is not required to, sign a formal complaint and move the case through a resolution process if the complainant declines to sign a formal complaint.

In a non-Title IX Sexual Harassment case involving sexual harassment, sexual assault, dating violence, domestic violence, stalking, or any other form of sex-based misconduct that is otherwise considered harassment under University policy but not defined as such pursuant to Title IX (hereinafter referred to as "University-Defined Sexual Harassment"), the complainant or the Title IX Coordinator will draft a complaint containing the complainant's allegations. Should the complainant decline to move forward with a resolution process pursuant to University policy, the Title IX Coordinator may file a complaint and move a case through a resolution process.

In both types of cases, once a complaint has been signed/finalized, the Title IX Coordinator will then assign an investigative team comprised of two trained co-investigators to begin interviewing involved persons (including the complainant and the respondent). The respondent and complainant may provide a written statement to the investigators at this time, and may identify potential witnesses.

All investigators receive annual training on issues related to dating violence, domestic violence, sexual assault, stalking, sexual exploitation, or any other form of sexual harassment or sexual misconduct covered by



University policy, as well as on the University's policies and procedures.

A Title IX Sexual Harassment case may be resolved without an adjudication or informal/formal resolution in certain circumstances:

1. the complainant requests dismissal of the formal complaint;
2. the Title IX Coordinator determines that specific circumstances prevent the University from gathering evidence sufficient to reach a determination; or
3. the respondent withdraws or is no longer employed by the University.

Similar circumstances may require a University-Defined Sexual Harassment case to also be resolved without an adjudication or informal/formal resolution.

### **Investigation**

The investigators will collect information and interview witnesses and other involved parties in an attempt to gather as much information as possible. Once the initial round of interviews and information gathering is complete, the investigators may exercise their discretion in whether or not to speak to any additional witnesses, collect any additional information, or ask follow-up questions of any witnesses.

In a Title IX Sexual Harassment case, all evidence collected during the investigation will be provided to the parties to inspect and review. The parties may submit written responses to the evidence. The investigators will also provide the parties with the opportunity to review the draft investigation report that summarizes relevant evidence. The parties may also submit written responses to the draft investigation report. The investigators will review any received written responses and may elect to make changes to the investigation report while finalizing the report. The investigators will provide the final investigation report, along with any written responses submitted by the parties during their review of the evidence and the draft investigation report, to the parties prior to any hearing.

In a University-Defined Sexual Harassment case, once the investigation is complete, the investigators will draft an investigation report that will include the information gathered and possible University policy violations based on the information gathered. The parties (and their advisors) may review the draft investigation report and provide comments concerning the information contained in the report. The investigators will review any

written responses and may elect to make changes to the investigation report while finalizing the report. The investigators will provide the final investigation report, along with any written responses submitted by the parties during their review of the draft investigation report, to the parties following transmission of the final investigation report to the Conduct Officer assigned to the case.

### **Informal Resolution**

In a Title IX Sexual Harassment case, at any time after a formal complaint has been filed, the parties may voluntarily choose to resolve the matter through informal resolution. The Title IX Coordinator will assess whether informal resolution is appropriate for the situation, and/or which form of informal resolution may be the most successful for the parties. Any party participating in an informal resolution may stop the process at any time and begin or resume the formal grievance process. Informal resolution may involve:

1. alternate resolution (such as mediation or restorative practices);
2. the respondent accepting responsibility for alleged policy violations, conditioned on whether the parties and the University can agree on responsibility, sanctions, and/or remedies; or
3. a negotiated agreement that resolves the allegations to the satisfaction of the parties and the University.

In a University-Defined Sexual Harassment case, a complainant may request to resolve a report utilizing the informal resolution process prior to the filing of a complaint, or any time after a complaint has been filed. The Title IX Coordinator will assess whether informal resolution is appropriate for the situation, and/or which form of informal resolution may be the most successful for the parties. Informal resolution may not be used in certain instances, including instances in which a complaint has been filed previously against the respondent. The informal resolution process is voluntary and involves having a facilitator help to resolve the issues between the parties. Informal resolution may involve asking the respondent to modify or stop the behavior, separating the complainant and the respondent, and/or reaching a mutually acceptable agreement. If informal resolution is unsuccessful or the complainant is dissatisfied with the informal resolution process, the complainant may terminate the informal resolution process at any time and proceed with a complaint and the formal resolution process.

### **Adjudication/Resolution/Sanctioning**

The manner in which the matter is resolved following the investigation and finalizing of the investigation



report differs depending on whether the situation involves Title IX Sexual Harassment or another form of sexual harassment or sexual misconduct (University-Defined Sexual Harassment).

In cases involving Title IX Sexual Harassment, typically, a pre-hearing meeting will be held with the parties and their advisors (either together or separately with each party/advisor) with the Chair of the hearing panel. A hearing panel of three faculty and staff members (with one of those individuals designated as the Chair) serves as the decision-maker in these cases. A live hearing will subsequently be conducted during which the parties and witnesses will be questioned and cross-examined, evidence presented, and evidentiary and credibility determinations made by the three-person panel.

Following the live hearing, the panel will deliberate in closed session to determine whether the respondent is responsible or not responsible for the policy violations in question. The resolution of the case is based on a preponderance of the evidence standard, meaning that it must be found more likely than not that the respondent violated University policy in order for the individual to be found responsible for a violation of University policy. If it is found more likely than not that a violation of University policy occurred, then the panel will consult with the Title IX Coordinator regarding the appropriate sanction(s)/disciplinary action. The Chair and the Title IX Coordinator will prepare and share a Notice of Outcome, a written document including the final determination, rationale, and any applicable sanction(s)/disciplinary action. The Notice of Outcome will be shared with the parties and their advisors simultaneously, in writing. This process, as a general matter, should take no more than 60–90 days from the initial filing of a formal complaint, either with or by the Title IX Coordinator. Timelines can be extended due to witness unavailability, holidays, or unexpected complexities with a matter.

In cases involving University-Defined Sexual Harassment, the resolution of the case differs depending on the role of the respondent at the University. Faculty cases are resolved by the Provost's Office, staff cases are resolved by the appropriate Senior Officer within the respondent's reporting line, and student cases are resolved by a three-person University Committee on Discipline (UCOD) panel comprised of faculty and staff. The investigation report is provided to the appropriate office/officer/panel to review and to question. In student cases, the investigation report is redacted of personally identifying information and transmitted to the Conduct Officer, who assigns the UCOD panel to decide the matter. After

reviewing the investigation report, the decision-maker (the Provost, Senior Officer, or UCOD panel) may question the investigators regarding the matter prior to determining whether the respondent is responsible or not responsible for the policy violations in question. The resolution of the case is based on a preponderance of the evidence standard, meaning that it must be found more likely than not that the respondent violated University policy in order for the individual to be found responsible for a violation of University policy. If it is found more likely than not that a violation of University policy occurred, then the decision-maker will consult with other University officials/offices (the Title IX Coordinator, Office of Human Resources, Office of Student Conduct & Community Expectations, etc.) regarding the appropriate sanction(s)/disciplinary action. In cases involving a student respondent and a finding of responsibility, the parties have the opportunity to submit Sanction Statements prior to a determination of the appropriate sanctions. The parties in University-Defined Sexual Harassment cases will be notified simultaneously in writing of the outcome of the case and sanctions imposed (as permitted/required by applicable law and University policy).

This process, as a general matter, should take no more than 60 days from the initial filing of a complaint, either with or by the Title IX Coordinator. Timelines can be extended due to witness unavailability, holidays, or unexpected complexities with a matter.

### **Outcomes/Sanctions**

Dating violence, domestic violence, sexual assault, stalking, sexual exploitation, and any form of sexual harassment or sexual misconduct are serious offenses that will not be tolerated in an educational, working, co-curricular, social, or living environment. Factors considered when determining a sanction/disciplinary action may include, but are not limited to:

- The nature, severity of, and circumstances surrounding the violation(s);
- The respondent's disciplinary history;
- Previous allegations or allegations involving similar conduct;
- The need for sanctions/responsive actions to bring an end to the Title IX Sexual Harassment and/or University-Defined Sexual Harassment;
- The need for sanctions/responsive actions to prevent the future recurrence of Title IX Sexual Harassment and/or University-Defined Sexual Harassment;
- The need to remedy the effects of the Title IX Sexual Harassment and/or University-Defined Sexual Harassment on the complainant and the community;

- The impact on the parties; and/or
- Any other information deemed relevant by the decision-maker and/or Title IX Coordinator.

Disciplinary action against faculty and staff may include:

- Warning – Verbal or Written
- Corrective Action or Restitution
- Performance Improvement/Management Process
- Required Counseling
- Required Training or Education
- Educational Sessions or Programs
- Work Restrictions
- Probation
- Loss of Annual Pay Increase
- Loss of Oversight or Supervisory Responsibility
- Reduction in Pay
- Demotion
- Suspension with Pay
- Suspension without Pay
- Termination (A move for dismissal of a tenured member of the faculty requires a special procedure involving the Board of Trustees, as per the Rules and Procedures of the Faculty.)

The range of disciplinary actions available under the Student Code of Conduct when students are found responsible for committing dating violence, domestic violence, sexual assault, stalking, sexual exploitation, or other form of sexual harassment or sexual misconduct may include the following:

- Expulsion
- Suspension
- Deferred suspension
- Disciplinary probation
- Disciplinary warning
- Other educational, punitive, or restorative sanctions
- Counseling
- Educational sessions or programs

## Appeals

Both parties in the case have the right to appeal the outcome and the sanction in cases involving dating violence, domestic violence, sexual assault, stalking, sexual exploitation, and other forms of sexual harassment and sexual misconduct as outlined in the applicable University policies.

In cases involving Title IX Sexual Harassment, a request for appeal must be submitted in writing to the Title IX Coordinator within three business days from the delivery of the Notice of Outcome letter. The grounds for appeal are:

1. Procedural irregularity that affected the outcome of the matter;
2. New evidence that was not reasonably available at the time the determination regarding responsibility or dismissal was made, that could affect the outcome of the matter; and
3. The Title IX Coordinator, investigators, or decision maker had a conflict of interest or bias for or against complainants or respondents generally or the specific complainant or respondent that affected the outcome of the matter. The appeal must be based on one (or more) of the three grounds mentioned above. The request for appeal should include specific details as to why an appeal should be granted. The appeal will be decided by a three-person appeal panel ("Appeal Panel"). The parties will be notified in writing of the outcome of the appeal, any specific instructions for remand or reconsideration, and any sanctions that may result which the University is permitted to share according to applicable law. The parties will also be notified in writing when the results of the process become final.

In cases of University-Defined Sexual Harassment, the grounds for appeal include:

1. Information is available that was not available at the time of the investigation;
2. The University disciplinary procedures were violated in a way that may have adversely affected the outcome of the case; or
3. The sanction is inappropriate (i.e., unduly lenient or unduly harsh).

In student cases of University-Defined Sexual Harassment, an appeal must be filed within three business days from the date of the outcome letter. The appeal must be submitted in writing and be based on one (or more) of the three grounds mentioned above. The letter should include specific details as to why an appeal should be granted, and should be submitted to the Conduct Officer. The Disciplinary Appeals Committee decides the outcome of student appeals. In faculty or staff University-Defined Sexual Harassment cases, an appeal must be filed within 14 calendar days of receiving written notice of disciplinary action. The appeal must be submitted in writing and be based on one (or more) of the three grounds mentioned above. The letter should include specific details as to why an appeal should be granted, and should be submitted to the appropriate entity for consideration. Faculty cases are decided by the Faculty Personnel Committee and staff cases are decided by the President of the University. In all University-Defined Sexual Harassment cases, both parties will be notified simultaneously in writing of the outcome

of the appeal, including notification of whether the appeal changes the initial outcome of the original decision-maker or requires additional process. Both parties will also be notified simultaneously in writing when the results of the process become final.

### **Records Requests**

Upon request, the University will disclose the results of any disciplinary proceeding conducted by the University against a student who is the alleged perpetrator of any crime of violence or a non-forcible sex offense, to the alleged victim or the alleged victim's next of kin, if the victim is deceased.

### **Confidential Reporting Options**

### **Programs to Prevent Dating Violence, Domestic Violence, Sexual Assault, and Stalking**

Lehigh's Prevention Programs include Primary Prevention Programs, Primary Awareness Programs, and Ongoing Prevention and Awareness Campaigns.

**Primary Prevention Programs:** The University implements programming, initiatives, and strategies, informed

by research or assessed for value, effectiveness, or outcome, that are intended to prevent incidents of sexual assault, domestic violence, dating violence, and stalking through the promotion of positive and healthy behaviors that foster healthy, mutually respectful relationships and sexuality, encourage safe bystander intervention, and seek to change behavior and social norms in healthy and safe directions. Each year, the Title IX Coordinator and the Director of the Office of Gender Violence Education & Support assess relevant data to determine strategies and programming to promote healthy relationships and prevent incidents of sexual assault, domestic violence, dating violence, and stalking.

**Primary Awareness Programs:** The University implements comprehensive, intentional, and integrated community-wide or audience-specific programming, initiatives, and strategies that increase audience knowledge and share information and resources to prevent sexual assault, domestic violence, dating violence, and stalking, promote safety, and reduce the perpetration of sexual assault, domestic violence, dating violence, and stalking.

**Ongoing Prevention and Awareness Campaigns:** Lehigh implements programming, initiatives, and strategies for students and employees that are sustained over time and focus on increasing understanding of topics relevant to, and skills for, addressing sexual assault, domestic violence, dating violence, and stalking using a range of strategies with audiences throughout the University.

Many of these programs and campaigns are described in the "Gender Violence Education & Support" section of this Report. Some of the programs and campaigns are also highlighted below.

During orientation programs for incoming students (including transfers and graduate students) and for new employees, students and employees are reminded that the University prohibits dating violence, domestic violence, sexual assault, stalking, sexual exploitation, and any other form of sexual harassment or sexual misconduct. The University's policies and procedures, along with appropriate resources, are also discussed.

The orientation programs for students also address consent, healthy relationships, bystander intervention and risk reduction, as well as the application of these concepts to their new college environment. For example, students discuss sex communication in the context of consent (providing verbal or non-verbal affirmative consent), as well as in the context of healthy relationships (considering your communication style in relationships). The Bringing in the

Bystander® program is highlighted during the orientation programs, highlighting the intervention decision-making process and discussing examples of bystander intervention in a college environment. Finally, risk reduction strategies are addressed, as discussed in more detail below.

These same topics are also addressed during numerous in-person and virtual training sessions conducted by the Office of Gender Violence Education & Support and the University's Equal Opportunity Compliance Coordinator/ Title IX Coordinator. These offices have collaborated with the Health Advancement and Prevention Strategies Office to offer additional educational opportunities to students regarding alcohol and drug use in the context of consent and sexual misconduct and the ways in which students can engage as bystanders in risky situations, and works with the Office of Fraternity and Sorority Affairs, Athletics Department, and Office of Student Engagement to provide educational opportunities tailored to specific student populations.

For employees, in addition to orientation sessions, the Title IX Coordinator conducts numerous in-person trainings on topics including sexual assault, stalking, dating violence, and domestic violence.

Online training modules discussing sexual assault, stalking, dating violence, and domestic violence is available for faculty, staff, and students annually. In addition, the University regularly engages external speakers/ consultants to present to faculty, staff, and/or students on a variety of topics relating to sexual assault, stalking, dating violence, and domestic violence. These topics have included consent and alcohol/drugs and mandatory reporting of sexual assault, stalking, dating violence, and domestic violence.

For the past few years, the Office of Gender Violence Education & Support has utilized the Bringing in the Bystander® program, an in-person educational program that encourages participants to become positive bystanders in instances of sexual and interpersonal violence and harassment by learning to identify problem situations and practical skills for safe and effective intervention. The Office of Gender Violence Education & Support has also recently joined the Know Your Power® campaign, an image-based social marketing campaign portraying realistic and provocative scenarios that highlight the important role of all community members in ending sexual and interpersonal violence and harassment. The Bringing in the Bystander® program and Know Your Power® campaign are the most recent efforts utilized to engage students in building skills to recognize instances of potential sexual



and interpersonal violence and to intervene to stop these instances. Previous campaigns and programs utilized by the University included the Red Flag campaign, Missoula's Intervention in Action Project, and the Step UP! Campaign, along with a program specifically developed by the Office of Gender Violence Education & Support and the Crime Victims Council of the Lehigh Valley for University students.

For employees, the University provides opportunities for participation each year in the University of New Hampshire's PowerPlay: Bystander Intervention workshops. These facilitated, interactive workshops utilize live actors to allow participants to identify incidents of bias and then build the ability to address these issues in a positive and constructive way.

### **Risk Reduction**

As explained more fully below, the University provides information on reducing risk of sexual misconduct, violence, or stalking in a variety of ways, and provides numerous opportunities for students and employees to increase both their knowledge on the risks and ways in which those risks can be addressed.

The University avoids victim-blaming language and techniques and instead provides strategies that may reduce risk and allow individuals to take an active role in increasing their safety or the safety of those they care about. Those strategies include: safety planning, including having a back-up plan; keeping an eye on friends; practicing safe drinking; trusting your instincts and checking in with yourself; and being aware of your surroundings.

LUPD offers instruction in the Rape Aggression Defense ("RAD") program to both male and female faculty, staff, and students. The RAD System is a program of realistic,



self-defense tactics and techniques. It is a comprehensive course that begins with awareness, prevention, risk reduction and avoidance, while progressing on to the basics of hands-on defense training. <https://police.lehigh.edu/content/rad-self-defense-training>

In addition, numerous trainings address the presence and use of rape drugs, and encourages awareness of those who have access to drinks and who have prepared or retrieved drinks. Finally, there are numerous workshops focused on healthy sexuality and healthy relationships in an effort to encourage and highlight appropriate behaviors.

The University also utilizes a free-to-download HawkWatch safety app which allows direct communication to Lehigh Police Dispatchers and alerts them to your specific location for a quicker response. ## Gender Violence Education and Support

The Lehigh University Office of Gender Violence Education and Support works to change campus climate around issues of Sex-Based Misconduct by supporting individuals experiencing Sex-Based Misconduct; reducing incidents of Sex-Based Misconduct among Lehigh students by increasing healthy relationships and consensual sexual encounters; and educating the campus community about healthy relationships, pleasurable consensual sexuality, Sex-Based Misconduct, and rape culture using evidence-based, intentional and appropriate trainings, events and initiatives. These initiatives include:

- **New Student Orientation:** Topics of Sex-Based Misconduct and healthy relationships are addressed during orientation through sessions that address Sex-Based Misconduct definitions and policies, reporting and resources, sexuality, consent, dating and relationships in college and bystander intervention and risk reduction.
- **5 x 10 Events:** As part of the Office of First Year Experience's 5 x 10 program, the Office of Gender Violence Education and Support annually brings a Sex-Based Misconduct speaker to campus. In addition to the speakers, weekly 5 x 10 workshops are offered that focus in more detail on the topics raised during orientation, such as LGBT Sex-Based Misconduct, drug- and alcohol-facilitated sexual assault and bystander intervention. Staff also answer any questions that new students may have about topics relating to Sex-Based Misconduct and healthy relationships.

- **Break the Silence Peer Educators:** Break the Silence Peer Educators, a project of the Office of Gender Violence Education & Support, is a student-run organization that focuses on "Preventing Gender Violence through Healthy Sexuality Education." Specially trained Break the Silence Peer Educators spread awareness and educate peers about Sex-Based Misconduct prevention, including sexual assault, intimate partner abuse, stalking, sexual exploitation, and harassment at Lehigh University. Break the Silence Peer Educators also conduct a variety of workshops on topics relating to healthy relationships and sexuality, ranging from "Popcorn and Porn" to "Ask a Sexpert" discussions. These are educational programs that help Lehigh's community have positive, healthy and safe sexual experiences and relationships.
- **Campus Wide Events:** Campus wide events are offered throughout the year in order to educate and raise awareness about Sex-Based Misconduct. Take Back the Night march and speak out is organized by members of Break the Silence each April and has become one of the most well-known and powerful events on campus. The office creates engaging and informative programming throughout the year based on student interest and campus need, such as its annual "Five Senses of Consent" event.
- **Awareness Months:** Additional events are held in recognition of Sex-Based Misconduct awareness months including domestic violence in October, stalking and human trafficking in January, and sexual assault in April.
- **Gender Violence Support Advocates Program:** The Advocates Program, supervised by the Office of Gender Violence Education & Support, is a network of dedicated and compassionate staff and faculty members who are trained to assist students who experience Sex-Based Misconduct. In their role, Advocates provide initial support and referrals to impacted students twenty-four hours a day, seven days a week, three hundred sixty-five days a year.

Through educational programming and events, the Office of Gender Violence Education and Support encourages students to examine their attitudes and beliefs about Sex-Based Misconduct, challenge rape culture, build healthy relationships and support students who experience Sex-Based Misconduct. Director Brooke DeSipio serves as a valuable resource for students who have experienced Sex-Based Misconduct or who are interested in learning more about the issues. The Director also serves as a valuable resource for family members and friends who want to learn more about how

## Registered Sex Offender Statement

The Campus Sex Crimes Prevention Act, a federal law, requires institutions of higher education like Lehigh to advise the campus community where information concerning registered sex offenders may be obtained. ## Lehigh's Drug, Alcohol and Substance Abuse Policy

Any person found responsible for illegal possession, distribution or consumption of any controlled substance, including alcohol, will be subject to disciplinary action by the University and may be subject to action by civil authorities.

### Students

Lehigh University prohibits the possession or use of alcoholic beverages by any student except when permitted by Pennsylvania law. Students found responsible for violating these policies face sanction by the Student Conduct System as well as possible referral to civil authorities. Lehigh University provides programming and educational opportunities to assist students in making good decisions regarding the use of alcohol and controlled substances.

In situations where a student's health or safety is at risk, peers are encouraged to seek medical attention for that student. Lehigh University has a medical amnesty

policy that allows students to seek help without concern for disciplinary action being taken against them or the person who is in need of help.

The Office of Counseling and Psychological Services is located on the fourth floor of Johnson Hall. Alcohol and other drug services are offered free of charge for a wide range of issues including substance use, abuse and dependency.

### Faculty and Staff

University employees found responsible for violating these policies face referral to Human Resources for staff and the Provost Office for faculty.

Employee Assistance Programs (EAP) are designed to assist employees during a variety of difficult times. The Lehigh EAP is managed by Uprise Health. Programs are available to eligible employees and any of their dependents who could benefit from their services. The program provides confidential access to professional counseling services for help in confronting such personal problems as alcohol and other substance abuse, marital and family difficulties, financial or legal trouble or emotional distress. ### Drug-Free Schools and Drug-Free Workplace Acts

We urge all students/faculty/staff to read the Report to the Campus Community concerning DRUGS and ALCOHOL: Striving for a Drug-Free Environment for Students and Employees at Lehigh University ([https://www.lehigh.edu/~policy/documents/FINAL-Fall\\_2022\\_Drug\\_Free\\_School\\_Zone\\_Report.pdf](https://www.lehigh.edu/~policy/documents/FINAL-Fall_2022_Drug_Free_School_Zone_Report.pdf)).

The Drug-Free Workplace Act of 1988 (P.L. 100-690) and the Drug-Free Schools and Communities Act Amendments of 1989 (P.L. 101-206) require that each college and University receiving federal financial assistance distribute annually certain information about drugs and alcohol to all of its students and employees.

This Report sets forth the University's standards of conduct prohibiting the unlawful possession, use or distribution of illicit drugs and alcohol by students and employees on its property or as part of its activities. It also includes a description of applicable drug and alcohol-related sanctions under local, Pennsylvania, and federal law; a summary of health risks associated with drug and alcohol use; a list of drug and alcohol counseling opportunities available to students and employees; and a discussion of sanctions related to drugs and alcohol that may be imposed by the University.

## Lehigh's Weapons Policy

Lehigh University police personnel are authorized to possess weapons on campus, and may do so within the scope of their authority.

To prevent personal injury, Lehigh prohibits the possession or use of any potentially dangerous weapon or explosive on University property. Such prohibited weapons include, but are not limited to, firearms, ammunition, air guns, spring-type weapons, slingshots and firecrackers. Violators of these regulations are subject to disciplinary action and contraband is subject to confiscation. Weapons under the control of the military departments are not subject to these regulations.

## Missing Student Policy

The Lehigh University Police Department (LUPD) will thoroughly investigate all reports of missing persons, whether they reside on or off-campus. To report a missing person, contact Lehigh Police at 610-758-4200, use one of the emergency phones, contact us through HawkWatch, or come to our station at 321 E. Packer Ave. Additionally, if you see a uniformed security guard or police officer on patrol, you can stop them and ask for their assistance in making a report. Lastly, you can always dial 9-1-1.

There is no waiting period required for reporting a missing person. Responding officers will carefully record and investigate the factual circumstances surrounding the disappearance in accordance with Departmental directives. Particular care will be exercised in the instances involving those who may be mentally or physically impaired, or others who are insufficiently prepared to care for themselves.

Students will have the opportunity to register a confidential emergency contact to be notified within 24 hours of the determination that the student is missing if the student has been determined missing by the LUPD or the local law enforcement agency. However, Lehigh is not precluded from contacting a student's contact person or custodial parent or guardian immediately upon determination that the student is missing. The emergency contact need not be a parent or guardian; it can be anyone. Registration is voluntary, but is strongly encouraged. The information provided is confidential, and will only be used by the Lehigh University Police Department in an emergency situation, including situations in which a student has been reported missing or

where disclosure is legally required by a search warrant or subpoena.

All students are required to complete a survey before registering for courses each semester. This survey requests that students review their emergency contact information on file to determine accuracy, or to add emergency contact information. Emergency contact information can be updated at any time through the Self-Service Banner, available at this link: <http://www1.lehigh.edu/insidelehigh>.

If the missing student residing on-campus has been missing for more than 24 hours, LUPD will notify the student's designated emergency contact, which is maintained in the Banner database. In addition to the contact person provided, if such a student is under the age of 18 and is unemancipated, the University will immediately notify the student's custodial parent or legal guardian and the student will be entered into the National Crime Information Center.

Reports of students missing from off-campus residences will be referred to the police department having jurisdiction over the student's local residence, if known, or the student's permanent residence if a local residence cannot be determined.

## Policies Concerning Students/ Employees with Criminal Records

Lehigh does not conduct background investigations on prospective students. If Lehigh receives information concerning a prospective student's criminal conduct, it is given appropriate consideration as necessary. Currently, enrolled students who are charged with and/or convicted of criminal offenses are subject to Lehigh's student judicial system and the full range of available disciplinary sanctions.

The Pennsylvania Child Protective Services Law (CPSL), as amended by Act 153, requires employees, volunteers and other individuals who interact with minors to obtain three different clearances. Act 153 states that all "school employees" who have "direct contact with children" are subject to certain requirements as a matter of state law. This includes undergoing a three-part criminal background check. As the law defines the terms "school employees" and "direct contact with children" – and in light of the number of Lehigh students who are minors as well as non-Lehigh student minors who frequent our campus, the University has determined that all current employees must undergo the Act 153 background checks. Lehigh University works with CBY, Inc., a vendor providing criminal background check services, to enable all staff and faculty to complete this required action as conveniently and efficiently as possible.

## Housing Information

Lehigh offers student housing in traditional residence halls, suites, apartments, fraternities and sororities. Housing at Lehigh is required through the second year. All residence halls are coeducational, with men and women living in the same building, on alternate floors or wings or in designated co-ed floors. All fraternity and sorority houses are single sex. There is also a gender-inclusive housing option. Each residence hall, fraternity house, and sorority house is equipped with a state-of-the-art security access system. Exterior doors are locked 24 hours a day, with resident card access.

### Off-Campus Living

Juniors and seniors who desire to live off campus must secure their own accommodations. ## Housing Assignments and Policies

### Occupancy

In a typical year, Lehigh University has more than 3,400 undergraduate students, and approximately 250 graduate students, living on campus.

All University residence halls will be open and available for student occupancy from August through May. During semester breaks, when classes are not in session, all residence halls will close for residents, except for in-season NCAA athletes, international students, and those with extenuating circumstances. Fraternity and sorority houses close during semester and spring breaks. Housing will be limited to the above-mentioned residents.

### Initial Assignments

First-year and transfer students are provided with initial residence hall assignments that take into consideration their social interests and needs as provided through a survey.

## Room Change Procedures

Room changes will generally not be authorized until after the first two weeks of classes each semester. Prior to any change, a student is required to discuss the reasons for such a request with the Residence Life staff. Room changes in Greek organizations must be authorized through house leadership.

## Residence Hall Housing After First Year

In a typical year, second-year students go through a housing selection process, while juniors and seniors who wish to live on campus participate in a housing lottery process. Both processes occur in the spring semester. Students may choose their rooms and room-mates. Students living off campus are also eligible to participate in the housing lottery to secure on-campus housing for the following year.

## Visitors

Any student who brings guests to campus is responsible for making University regulations known to them, and must accept responsibility for their guests' conduct during the visit. In a typical year, guests may not be housed for extended periods of time without written permission of the Office of Residence Life. The housing of a guest must not infringe upon the rights of the roommate(s) and other residents of the living unit.





## Campus Safety Awareness and Crime Prevention

In an effort to promote campus safety and security awareness throughout the year, members of the Lehigh University Police Department engage with students, faculty and staff to offer and provide a variety of campus safety awareness as well as crime prevention programming.

One of the essential components of any successful crime prevention program is an informed public. It is the intent of Lehigh University Police Department to inform all students, faculty and staff of campus safety awareness resources as well as crime prevention programming. All crime prevention and safety awareness programs encourage students, faculty and staff to be responsible for their own safety and the safety of others. Participants in these programs are asked to be alert, security conscious, involved and are advised to call the Lehigh University Police Department to report suspicious behavior.

Annually, during Freshman Orientation, the Lehigh University Police Department partners with the Dean of Students Office and Residence Life to provide all incoming students as well as other interested community members with in person discussions regarding crime prevention and safety awareness programming.

The Lehigh University Police Department also provides crime prevention and safety awareness information during new employee orientation to newly hired staff, which is held on a quarterly basis and it offers an opportunity to provide crime prevention programming tailored to any Department upon request throughout the year.

### Safety Awareness Programs include information on the following:

- **Alcohol Awareness**—This presentation focuses on the effects of alcohol and the laws and consequences. Fatal Vision goggles are used as part of this demonstration.
- **Drug Awareness and Recognition**—This program outlines the most abused drugs on campus, warning signs of abuse and how these drugs affect students and the community.
- **Identity Theft & Theft Prevention**—Officers present information and precautions to be taken to minimize the risk of becoming the victim of theft and identity theft.

- **Off-Campus Safety**—Officers provide information on navigating the off-campus area in a safe manner.
- **On-Campus Safety**—Officer(s) meet with student housing leaders, fraternities, sororities, athletic groups or any other campus group to discuss matters related to Lehigh University social policy, crime prevention, and PA laws.

### Crime Prevention Programs include information on the following:

- **R.A.D (Men/Women)**—Officer(s)/certified instructors provide comprehensive course instruction to students, faculty and staff and provide realistic self-defense tactics and techniques. The course begins with awareness, prevention, risk reduction and avoidance, while progressing to the basics of hands-on defense training (annually).
- **Active Shooter Program**—Officer(s) provide the requesting group with a detailed emergency response/reaction plan to an active shooter situation (annually).

Officer(s) provide the following information:

- Run - Hide - Fight philosophy
- Police response for these types of situations
- Lehigh University emergency notification procedures
- Prevention of such incidents
- **Orientation**—Officers(s) provide incoming undergraduate, graduate and international students with crime prevention information and safety techniques. Officer(s) provide new students with information on PA law, Bethlehem city ordinances, and Lehigh University social policies. Officer(s) provide Orientation Leaders and LU Gryphons with training to assist with their daily responsibilities in campus housing and scenario-based training with a question and answer period at the end of each session (annually).
- **Resource Tables**—Officer(s) set up designated tables throughout the year to inform and provide students, staff and community members with crime prevention materials. Students, staff and community members also have the opportunity to sign up for certain Lehigh University Police-offered programs via tablets (annually).
- **LUPD security surveys**—Officer(s) perform security surveys/assessments upon the request of tenants, landlords or faculty, including a detailed report that can be shared (annually).

- **Safety Escorts**—The escort service provides an alternative to walking alone after dark. The service is designed for students but is open to the entire University community. The service operates between dusk and dawn throughout the school year. It provides either a walking or driving escort, depending on the time of night and the weather. Walking escorts can be requested by contacting the Lehigh University Police at 610-758-4200 (annually).

## Daily Crime and Fire Log

The Lehigh University Police Department maintains a combined Daily Crime and Fire Log containing all incidents reported within our Clery Act Geography. This includes all Clery Act crimes and fire-related incidents that occur on campus, in or on noncampus buildings or property, on public property, or within our patrol jurisdiction.

The Daily Crime and Fire Log includes the incident type, the date on which the incident was reported, the date and time of occurrence, and the general location of each reported incident type, as well as the disposition of the incident, if this information is known. The Lehigh University Police Department posts specific incidents in its Daily Crime and Fire Log within two business days of receiving a report of an incident, and reserves the right to exclude reports from a log in certain circumstances, as permitted by law.

The past 60 days of information is available for review in the lobby of the Lehigh University Police headquarters, located at 321 East Packer Avenue. In addition, a 60-day Daily Crime and Fire Log is available for public inspection online at <https://police.lehigh.edu/crime-log>.

The Lehigh University Police Department also maintains a seven-year archive of the Daily Crime and Fire Log. Requests for information older than 60 days must be directed to the Lehigh University Police Department by phone at 610-758-4200 or by email [inlpd@lehigh.edu](mailto:inlpd@lehigh.edu). Information will be made available within two business days of a request for public inspection.

## The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (The Clery Act)

The Clery Act (The Clery Act 20 U.S.C. § 1092(f)) requires Lehigh University to provide students and employees with information on its security policies and procedures and specific statistics for certain criminal incidents, arrests and disciplinary referrals and to make the information and statistics available to prospective students and employees upon request. This information is available by calling the Lehigh University Police Department at 610-758-4200 or visiting <https://police.lehigh.edu/content/clery-act-information-statistics>.

The Lehigh University Police Department (LUPD) maintains close relationships with all police departments that have jurisdiction in the areas in which Lehigh University owns or controls property. Crimes reported to local police departments that involve University property are brought to the attention of the LUPD. In addition to requesting Clery crime statistics from local police departments, all reports of crime incidents, made directly to the LUPD through Lehigh Police Officers, the Lehigh Police Dispatch Center, and Lehigh University Security Guards, as well as all incidents reported to Campus Security Authorities, are entered into an integrated computer-aided dispatch/records management system. All entries are recorded in this system in accordance with the crime definitions outlined in the FBI Uniform Crime Reporting handbook.

All crimes reported to LUPD, by any source, will be reviewed by a police supervisor to ensure they are classified according to the proper crime category. Police supervisors audit all reports to ensure that information is being collected and entered properly according to crime classifications and are accounted for in crime statistics, as well as in the Daily Crime Log.

Statistics reported for each of the liquor law, drug law, and weapon offenses subcategories represent the number of people arrested or referred to campus judicial authorities.

It is important to note that the crime classifications for which colleges and universities must provide statistics differ under state and federal law; therefore, statistics for certain crime classifications might appear to be different depending on the entity by which they are displayed. For example, the federal statistics for motor vehicle theft differ from the state statistics for the same category because the federal classification includes attempted



motor vehicle thefts, while state law requires institutions to separately report attempted motor vehicle thefts and completed motor vehicle thefts.

**Definitions of Crimes Reportable Under The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, as Amended by the Higher Education Opportunity Act & the Violence Against Women Act (Clery Act Offenses):**

**Criminal Homicide**

**Murder:** The willful (non-negligent) killing of one human being by another.

**Manslaughter**

**Non-negligent Manslaughter [Murder]:** The willful (non-negligent) killing of one human being by another.

**Manslaughter by Negligence [Criminal Homicide]:** The killing of another person through gross negligence.

**Sex Offenses**

**Rape:** The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration of a sex organ of another person, without the consent of the victim.

**Fondling:** The touching of the private body parts of another for the purpose of sexual gratification, without

the consent of the victim, including instances where the victim is incapable of giving consent because of his/her temporary or permanent mental or physical incapacity.

**Incest:** Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

**Statutory rape:** Sexual intercourse with a person who is under the statutory age of consent. In Pennsylvania, it is illegal for an adult (someone 18 or older) to have sex with a minor (someone younger than 16), even if the sex is otherwise “consensual.”

**Robbery:** The taking or attempting to take anything from the care, custody, or control of a person or persons by force, or threat of force, or violence and/or by putting the victim in fear.

**Aggravated Assault:** An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of attack is usually an assault, accompanied by the use of a weapon or by means likely to produce death or great bodily harm. (It is not necessary that injury results from an aggravated assault when a gun, knife, or other weapon is used, which could, and probably would, result in serious personal injury if the crime were successfully completed.)

**Burglary:** The unlawful entry of a structure with intent to commit a felony or a theft. For reporting purposes, this definition includes: unlawful entry with intent to commit a larceny or felony; breaking and entering with intent to commit a larceny; housebreaking; safecracking; and all attempts to commit any of the aforementioned.

**Motor Vehicle Theft:** The theft or attempted theft of a motor vehicle. (Classify as a motor vehicle theft all cases in which automobiles are taken by persons not having lawful access even though the vehicles are later abandoned, including joyriding.)

**Arson:** Any willful or malicious burning, or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

**Domestic Violence:** a felony or misdemeanor crime of violence committed:

- by a current or former spouse or intimate partner of the victim;
- by a person with whom the victim shares a child in common;
- by a person who is cohabitating with, or has cohabitated with, the victim as a spouse or intimate partner;
- by a person similarly situated to a spouse of the victim under domestic or family violence laws of the jurisdiction in which the crime of violence occurred; or
- by any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred.

**Dating Violence:** Violence committed by a person who is, or has been, in a social relationship of a romantic or intimate nature with the victim. The existence of such a relationship shall be determined based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship. For the purposes of this definition, dating violence includes, but is not limited to, sexual or physical abuse or the threat of such abuse. Dating violence does not include acts covered under the definition of domestic violence.

**Stalking:** Engaging in a course of conduct directed at a specific person that would cause a reasonable person to fear for the person's safety or the safety of others, or suffer substantial emotional distress.

**Hate Crimes:** Includes all of the crimes listed above, where the law requires the release of statistics by

category of prejudice, in which the victim was intentionally selected because of the perpetrator's bias against the victim based on one of the Categories of Prejudice listed below, plus the following crimes:

**A. Larceny Theft:** The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another.

**B. Intimidation:** To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

**C. Destruction/Damage/Vandalism of Property:** To willfully or maliciously destroy, damage, deface, or otherwise injure real or personal property without the consent of the owner or the person having custody or control of it.

**D. Simple Assault:** An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

### **Categories of Prejudice under Hate Crimes are as follows:**

**A. Race:** A preformed negative opinion or attitude toward a group of persons who possess common physical characteristics genetically transmitted by descent and heredity that distinguish them as a distinct division of humankind.

**B. Gender:** A preformed negative opinion or attitude toward a person or group of persons based on their actual or perceived gender, e.g, male or female.

**C. Religion:** A preformed negative opinion or attitude toward a group of persons who share the same religious beliefs regarding the origin and purpose of the universe and the existence or nonexistence of a supreme being.

**D. Sexual Orientation:** A preformed negative opinion or attitude toward a group of persons based on their actual or perceived sexual orientation – a person's physical, romantic and/or emotional attraction to members of the same and/or opposite sex, including lesbian, gay, bisexual, and heterosexual (straight) individuals.



**E. Ethnicity:** A preformed negative opinion or attitude toward a group of people whose members identify with each other, through a common heritage, often consisting of a common language, common culture (often including a shared religion), and/or ideology that stresses common ancestry.

**F. National Origin:** A preformed negative opinion or attitude toward a group of people based on their actual or perceived country of birth.

**G. Disability:** A preformed negative opinion or attitude toward a group of persons based on their physical or mental impairments, whether such disability is temporary or permanent, congenital, or acquired by heredity, accident, injury, advanced age, or illness.

**H. Gender Identity:** A preformed negative opinion or attitude toward a person or group of persons based on their actual or perceived gender identity.

**Weapon Law Violations:** The violation of laws or ordinances dealing with weapon offenses, regulatory in nature, such as: manufacture, sale, or possession of deadly weapons; carrying deadly weapons, concealed or openly; furnishing deadly weapons to minors; aliens possessing deadly weapons; and all attempts to commit any of the aforementioned.

**Drug Abuse Violations:** Violations of state and local laws relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The relevant substances include: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics (Demerol, methadone); and dangerous non-narcotic drugs (barbiturates, Benzedrine).

**Liquor Law Violations:** The violation of laws or ordinances prohibiting: the manufacture, sale, transportation, furnishing, or possessing of intoxicating liquor; maintaining unlawful drinking places; bootlegging; operating a still; furnishing liquor to a minor or intemperate person; using a vehicle for illegal transportation of liquor; drinking on a train or public conveyance; and all attempts to commit any of the aforementioned. (Public Drunkenness and Driving Under the Influence are not included in this definition.)

Referrals for Disciplinary Actions by Student Conduct must be reported to the Lehigh University Police for the following: Illegal Weapons Possession; Violations of Drug Laws; Violations of Liquor Laws.

## Campus Crime Statistics for Lehigh University

The law requires statistics for an expanded area beyond the campus and it requires these statistics to be shown in specific geographic categories. (Note that incidents shown in the On-Campus Residential category are also included in the statistics shown in the Campus category.) The following statistics are provided in compliance with the specific time periods, crime classifications, geographic categories and arrest data mandated by federal law.

The Clery Act defines [Clery Act Geography](#) as:

- **On-Campus** as “any building or property owned or controlled by an institution of higher education within the same reasonably contiguous geographic area of the institution and used by the institution in direct support of, or in a manner related to, the institution’s educational purposes, including residence halls; and property within the same reasonably contiguous geographic area of the institution and is owned by the institution but controlled by another person, is used by students, and supports the institutional purposes, such as a food or other retail vendor.”
- **On-Campus Residential** is a sub-category of Campus showing the number of on-campus incidents that occur “in dormitories or other residential facilities for students on campus.”
- **Non-Campus Building or Property** as “any building or property owned or controlled by a student organization recognized by the institution; and any building or property, other than a branch campus, owned or controlled by an institution of higher education that is used in direct support of, or in relation to, the institution’s educational purposes, is used by students, and is not within the same reasonable contiguous geographic area of the institution.”
- **Public Property** as “all public property that is within the same reasonably contiguous geographic area of the institution, such as a sidewalk, a street, other thoroughfare or parking facility, and is adjacent to a facility owned or controlled by the institution if the facility is used by the institution in direct support of, or in a manner related to the institution’s educational purposes.”

## The Pennsylvania Uniform Crime Reporting Act

The Pennsylvania Uniform Crime Reporting Act requires the release of crime statistics and rates to students and employees, and it requires that those statistics be available to applicants and new employees upon request. The rate is based on the actual number of Full Time Equivalent (FTE) students and employees, calculated according to a state-mandated formula. The index in the table below is based on incidents per 100,000 FTEs. The University's FTE population for 2019 was 8,309; and for 2020 was 8,268; and for 2021 was 8,588.

## Annual Fire Safety Report

### Policy Statement

The University is committed to providing residents, employees and guests of on-campus student housing facilities with a safe environment in which to live, learn, and work. It is the responsibility of all residents, employees and guests to abide by all fire safety rules, regulations, and guidelines.

### Fire Reporting

If a fire is discovered, community members should immediately notify Lehigh police by activating the nearest pull station, calling x84200 from any campus phone, calling 610-758-4200, or calling 9-1-1. Lehigh police will initiate an immediate response by the Bethlehem Fire Department. If a member of the Lehigh community finds evidence of a fire that has been extinguished, and the person is not sure whether Lehigh police has already responded, the community member should immediately notify Lehigh Police to investigate and document the incident.

### Responding to Alarms

The Lehigh University Police Department and City of Bethlehem Fire Department respond to all fire alarms in on-campus student housing facilities. Lehigh police arrive at the scene of a fire alarm first, and communicate the severity of the emergency to the City of Bethlehem Fire Department while its members are en route. All occupants of the impacted building are required to evacuate the building upon hearing the alarm.

In the event of an actual fire or sprinkler discharge in an on-campus student housing facility, Lehigh police will contact the Dean of Students staff member and the Housing Services staff member who are on-call. The on-duty personnel will contact additional departments and individuals as needed.

### Evacuation

The University expects all residents, employees, and guests to evacuate an on-campus student housing facility upon hearing a fire alarm. Individuals should evacuate through the nearest exit, in accordance with the fire evacuation map located in all hallways throughout the residential system.

Once you have exited the building, you must remain outside the facility, and gather a safe distance from the building and emergency personnel. No one may reenter the building until the City of Bethlehem Fire Department has communicated that the building may be safely reoccupied.

Additionally, all residents, employees and guests should follow these guidelines:

- Use stairways; never use an elevator
- If conditions permit, close all open doors to in order to contain the fire and smoke
- If smoke-filled conditions exist, crawl low to the floor, under the smoke, to the nearest exit
- If you must exit through a door, touch the door and the knob with the back of your hand; if it is hot, try another escape route
- If you are trapped in your room, seal the door with rags and signal from your window; call x84200 or 9-1-1 to let Lehigh police know your location

### Residential Fire Safety Systems

All on-campus student housing facilities at Lehigh University contain the following fire safety systems:

- hard wired smoke detectors in every room
- audible alarms which report back to the Lehigh University Police Department
- complete sprinkler installation
- fire extinguishers on every hallway, in every common kitchen area and near all individual apartment kitchens

All fire safety systems are checked on a monthly basis. A detailed description of all fire safety systems can be found at Housing Services.

### Fire Extinguishers

There is a fire extinguisher placed in all hallways and common areas throughout our residential system. The extinguishers are to be used by emergency responders and trained University personnel only. Do not attempt to fight a fire with an extinguisher unless you have been appropriately trained on the proper use of the equipment. If you discover a small fire and the alarm fails to sound, go to the nearest pull station and activate the alarm and evacuate the building immediately. Fire extinguishers throughout our residential system are inspected on a monthly basis to ensure their proper charge and functionality.

### Fire Drills

Fire drills for on-campus student housing facilities are scheduled and conducted twice per year in accordance with the Pennsylvania State Fire Code. For the number of fire drills conducted in each on-campus student housing facility, please see the charts on pages 49 to 54 of this report.

Fire drills are conducted by the Office of Housing Services in conjunction with the Office of Facilities and the Lehigh University Police Department. Results of each fire drill are sent to the City of Bethlehem Fire Department and are on file at Housing Services. Poor evacuation times will result in retesting.

## Individuals with Disabilities

Any individuals with disabilities who require assistance evacuating a building should notify the Lehigh University Police Department, Disability Support Services and Housing Services, prior to an emergency so that an evacuation assistance plan can be made for you with assistance from the Bethlehem Fire Department.

## Fire Inspections

Housing Services, in conjunction with the Office of Residence Life, conduct fire safety inspections in all on-campus student housing facilities during the month of October. These inspections are conducted to ensure that the fire safety policies, which are outlined in our General Provisions for Student Occupancy, are being followed.

## Prohibited Items and Activities

The General Provisions for Student Occupancy (housing contract) outlines prohibited items and activities in our Residential System. Some of these include:

- smoking in any residential facility
- hanging items from or blocking access to sprinkler heads
- open flames of any kind and candles—any type including religious or decorative
- halogen lamps
- non-University issued space heaters
- small portable cooking appliances, including hot plates, toaster ovens and microwaves
- electric blankets
- refrigerators exceeding 5.2 cubic feet
- decorations which violate the provisions outlined in the General Provisions for Student Occupancy (housing contract)

As a tobacco-free and smoke-free campus, Lehigh also prohibits all tobacco use—including smoking, vaping, hookahs, electronic smoking devices, and using smokeless tobacco products and chewing tobacco—in all Lehigh University facilities, properties, grounds, and vehicles and across all campuses indoors and outdoors. ## Furniture

All furniture supplied by the University meets the requirements of Cal Tech 133, and University-supplied mattresses meet Cal Tech 117. These measurements are standards, used throughout the furniture industry, regarding the combustibility requirements of residential furnishings. We strongly recommend that student-owned

furniture brought into our residential system conform to the same guidelines.

## Student Training

Residents of on-campus student housing facilities are trained in basic fire safety policies by the Residential Life Staff in Residence Halls or by Housing Services Staff in Fraternities and Sororities. This training is conducted at mandatory floor and house meetings at the beginning of each academic year. Fire safety residential policies and systems such as the below are reviewed:

- smoke detectors
- fire alarm pull stations
- fire extinguishers
- sprinkler heads
- emergency exit lighting and signage
- emergency evacuation routes
- proper evacuation protocol in the event of a real fire

The same information is covered for new residents who move into facilities during or between semesters.

## Fire Safety Programming

The importance of fire safety at Lehigh University is highlighted during National Fire Safety Week, which takes place each year in October.

Examples of programming emphasizing fire safety in residential areas are:

- Showing of videos on how quickly residential rooms can catch fire and burn
- Visits from the City of Bethlehem Fire Chief to discuss fire safety
- Discussions on how fire safety is everyone's responsibility

## Future Improvements in Fire Safety

Lehigh University continues to monitor trends related to on-campus student housing facility fire incidents and alarms to provide a fire-safe living environment for all residents. New programs and policies are developed as needed to help ensure the safety of all residents, employees and guests.
